Dear Prime Minister and Minister Fraser,

Re: Immigration Status Regularization - Permanent Residence For All

The Canadian Centre for Torture Victims (CCVT) welcomes your government's promise to introduce a regularization program for undocumented migrants – stated in the mandate letter of the Minister of Immigration Refugees and Citizenship and encouraged by a unanimous Parliamentary motion calling for a program to be introduced by Fall 2022.

The Canadian Centre for Torture Victims (CCVT) aids survivors of torture, war, genocide, and crimes against humanity to overcome the lasting effects of torture and war. Working with the community, the Centre supports survivors in the process of successful integration into Canadian society, works for their protection and integrity, and raises awareness of the continuing effects of torture and war on survivors and their families. The CCVT gives hope after the horror.

Many people in Canada have no immigration status or only precarious status. Many of those with precarious or no status are racialized and many are women. This Fall, your government has a historic opportunity to introduce a long overdue change to create a permanent, comprehensive, inclusive, and accessible regularization program. We urge you to introduce a program that will extend permanent residence to all refugees and migrants, including 500,00 undocumented migrants – thus giving equal rights to all, rather than a small and restrictive program that will give permanent residence for just a few.

We urge you to implement the recommendations in the comprehensive regularization proposals from Canadian Council for Refugees and the Migrant Rights Network. Both organizations propose a comprehensive program that will include every person in Canada without immigration status or precarious status, is built on a human rights framework and leaves no one behind. CCVT is a member of both networks and wholeheartedly supports both proposals.
