As an organization that advocates for the rights of refugees and migrants in Canada, we are encouraged by the efforts to create a broad regularization program for undocumented migrants, migrant workers, students, families, and refugees. We call on you to fulfill Canadian commitments to human rights, and appeal that it not be a small exclusionary program that grants rights to a few and denies them to most. Aligned with thousands of advocates across the country, we are requesting a broad regularization program that extends permanent residence to 1.7 million migrants. A program that leaves no one behind.

Citizens for Public Justice endorses the [proposals established by the Migrant Rights Network](#) to guide the development of a regularization program. It is crucial

that programs and policies are informed by the individuals and groups that are most impacted. We ask that you take into account these proposals developed through migrant organizing, which reflect the needs and demands of migrants across the country.

The Trudeau government has committed itself to the values of equality and anti-racism, and to welcoming migrants and refugees. We therefore invite you to use this opportunity to fulfill such commitments with action by redressing the historic injustice of excluding thousands of migrants from equal status through a comprehensive regularization program that leaves no one behind.

Tragically, Canada has a history and legacy of exclusionary immigration policies that counter the values and image we claim to hold and portray. Many people who play integral parts in Canadian society have been left out of pathways to permanent residency. We have seen the devastating effects that the lack of permanent status has had on many migrants in Canada, such as poor health outcomes, high poverty levels, and separated families. Many are stuck in exploitative, low-wage jobs with precarious status while providing essential services. They lack equal rights at work, school, and limited access to healthcare and other basic services.

The implementation of a broad regularization program gives the opportunity to uphold the values of equality and justice, and move towards what Canada aims to be: a nation that provides a fulsome welcome to migrants and refugees from around the world.

We urge you to consider the proposals referenced above and implement a comprehensive program that allows migrants to participate more fully in our communities, and grants them access to fundamental human rights in Canada.
